Other taxes such as VAT and Council Tax do not qualify. The Urology Foundation will reclaim 28p of tax on every £1 that you donated up to 5 April 2008 and will reclaim 25p of tax on every £1 that you give on or after 6 April 2008.

If you pay income tax at the higher rate or additional rate, and want to receive the additional tax relief due to you, you must include all your Gift Aid donations on your Self-Assessment tax return or ask HM Revenue and Customs to adjust your tax code.

Gift Aid – The Facts

Gift Aid is a simple way for charities or Community Amateur Sports Clubs (CASCs) to increase the value of gifts of money from UK taxpayers by claiming back the basic rate tax paid by the donor. When The Urology Foundation receives a donation we are entitled to claim the tax paid on that donation.

How does it work?

If you give £100 donation to TUF we will receive exactly £100. But if you Gift Aid it we will receive £125, increasing the value of your gift by 25%. We will claim the Gift Aid from the HMRC (HM Revenue and Customs) so you won't pay any extra but your donation increases thanks to Gift Aid.

Once you have given us permission to do this on your behalf (by filling out this Gift Aid Declaration Form) there is no need for you to do anything else.

Who qualifies for Gift Aid?

If you pay enough income tax or capital gains tax to cover the 20 per cent tax we reclaim you are eligible to take part. Other taxes such as VAT and Council Tax do not qualify. If you are eligible please complete this Gift Aid Declaration so we can reclaim the tax on your donations to TUF.

You must give a separate declaration to each charity you want to donate to through Gift Aid.

Does your Gift Aid Declaration need to be renewed each tax year?

No, you only need to make the declaration once. It will apply to all donations you have made in the last four years as well as to all future donations.

If you stop playing tax please contact us as we will not be able to claim Gift Aid on your future donations to TUF.

What if you pay a higher rate of tax?

If you are a donor and pay tax at a rate of 40% or above you can benefit from tax relief by claiming back the difference between the higher and basic rate on your donation. You can do this through your Self-Assessment tax return or by asking the HMRC to amend your tax code.

With Payroll Giving you do not pay the difference between the higher and basic rate of tax on your donation.
